SUPPLEMENTARY LEASE DEED

Through this Supplementary Lease Deed the parties hereto agree to completing the original Lease Deed dated 27.05.2011 registered with Sub-Registrar, Gautam Budh Nagar, Greater Noida vide Bahi No.1 Jild No. 8610 Page No. 141 to 192 Sr.No. 9405 executing and registering the Group Housing/Builders Residential Sub Divided Plot No. GH-06A, Sector-01, Greater Noida by adding the remaining area of 2193.94 sq.mtr

In page 2 (typed portion) on the main Lease Deed dated 27.05.2011 it is mentioned that "the total area of the plot as per lease plan is 23912.50 sq. mtr. out of which 2193.94 sq.m. are not in the possession of the Authority, hence its possession would be given later after execution of supplementary lease deed. Presently lease deed of clear area 21718.56 sq.mtr is being executed and consideration is determined through this lease deed".

LESSEE This in consideration of the total proportionate premium of the 2193.94 sq.m. is Rs. 2,24,22,067.00 out of which approx 10% premium of allotted area (2081.44 sqm.) and entire amount Rs. 11,49,750.00 of excess area (112.50 sqm.) have been paid by the Lessee to the Lessor (the receipt whereof the Lessor doth hereby acknowledge). The balance 90% premium of the allotted area of plot along with interest will be paid in 16 half yearly installments as per intimated payment plan.

Now the Lessor has got the possession of affected area i.e. 2193.94 sq.m.. Lessee has requested the Lessor to hand over of this clear area i.e. 2193.94 sq.m., after execution of this Supplementary Lease Deed.
