8. The statements contained in paragraphs 1 to 7 of the foregoing Affidavit are true to my knowledge.

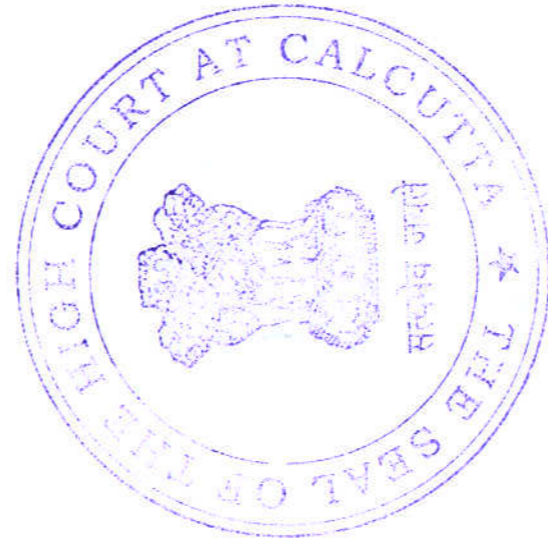
