- 1. With reference to point 1 of the said letter wherein it has been mentioned to provide the details of the projects launched by the promoter in past 5 years, the said details have been uploaded.
- 2. With respect to Point 2 of the said letter, the error while mentioning longitude and latitude has been rectified.
- 3. With respect to Point 3 of the said letter, the revised map sanctioned by Lucknow Development Authority in accordance to the details mentioned under "Details of Apartment/Flat/Shop/Plot" has been uploaded.
- 4. With respect to Point 4 of the said letter, the details of the contractor have been uploaded. However, the brief details of the development work applicable on the project have already been mentioned. Since the project "ORO Atrium" for which registration has been applied for is a commercial project and also a part of our township "ORO City", therefore certain development works are not applicable on it & has been specified so.

M/S Ajit Constructions through this consortium has been appointed/authorized as the lead member, who further executed another consortium agreement dated 19.11.2016 with ORO Constructions Pvt. Ltd. For the development of project in village- Madiyaon, Distt- Lucknow which is registered in the office of S.R. Third at book no. 4 Jild 491 pages 221/276 at serial no. 815 on 19.11.2016.

M/S Ajit Constructions through its partner Mr. Ajit Maurya who is also one of the director in ORO Constructions Pvt. Ltd. Indemnifies the ownership of the land whereas ORO Constructions Pvt. Ltd. Through its director Mr. Dinesh Kumar indemnifies the development/construction of the project.

Both these consortium agreements have been uploaded on the RERA website.

6. With respect to Point 7 of the said letter, the project lies on Khasra No 652 & the NEC of the same is already uploaded. Revised affidavit with 59 months as project completion period has been uploaded.
