3. With reference to point 3 of the said letter, wherein a query has been raised that the latitude and longitude is not in the prescribed format with regard to the same we wish to submit that the error has now been rectified.

With reference to point 4 of the said letter, wherein a query has been raised that the supply source is not shown in electricity supply plan and STP is not shown in waste disposal plan and the water supply source is not demarcated in the water supply plan, with regard to the same we wish to submit that STP is not mandatory in this size of plot. Sewage will directly connect to the main sewer line. Beside Electric supply will be directly from the power corporation line and Water supply will be through a boring and municipal water line. The service plans showing above particulars have been duly uploaded on the portal.
5. With reference to point 5 of the said letter, wherein a query has been raised that legends are illegible in the uploaded approved map, layout and Floor Plan, with regard to the same we wish to submit that the proper legible copy of the approved maps, floor plans has now been uploaded.
6. With reference to point 6 of the said letter, wherein a query has been raised that Quarterly Targets are not properly bifurcated with regard to the same we wish to submit that all the details have already been bifurcated properly and no amendments are required in that case as we are planning to complete the construction as per the given schedule.





4. The supply source is not shown in the Electricity supply plan and STP is not shown in the waste disposal plan. The water supply source is not demarcated in the Water supply plan.
5. Legends are illegible in the uploaded approved map, layout, and Floor Plan.
6. Quarterly targets are not properly bifurcated.
