- 1. With reference to point no. 1 wherein a query has been raised that the website of the Project, as uploaded by the promoter, is inapt/irrelevant. In this regard, we wish to submit that we updated the website and disclosed the name of the project and promoter on the same.
- 2. - 5. With reference to point no. 5 wherein a query has been raised that no Khatauni has been uploaded under Project's Land detail. In this regard, we wish to submit that the same has now been uploaded properly on the portal.
- 6. With reference to point no. 6 wherein a query has been raised that the name of Promoter in Form-B is wrongly mentioned. In this regard, we wish to submit that we have corrected the Promoter's name and uploaded the rectified Affidavit in Form-B on the portal for your consideration.
