With reference to point no. 2 wherein a query has been raised to explain the timeline of 58 months for development of 46 plots, in this respect we wish to submit that UP Awas Vikas has sanctioned our maps with the validity of 5 years i.e. upto 09.01.2027, and as per section 4(2)(1)(C) of RERA 2016 promoter is required to fill the date of completion of the project. With reference to point no. 5 wherein a query has been raised to upload latest khatauni extract and highlight the khasra no. and the latest ownership, with regard to the same we would like to inform that the project land is not agricultural and is of urban use only since beginning, The land has been purchased by HDFC through a single sale deed dated 15.12.2021 which is already uploaded on RERA, Since the land use is not converted from agricultural to urban, we are unable to upload latest khatauni extract on RERA portal.
- 6. With reference to point no. 6 wherein we have been asked to upload an affidavit mentioning details of bookings/Sales for the project till the latest date and also confirm that there is no other project registered in RERA, with regards to the same we would like to inform such certificate is already uploaded on RERA portal under "Other Plan" tab.
- 7. With reference to point no. 7 wherein query has been raised to upload Encumbrances detail cum land title search report from an advocate having 10 years of experience in land-related matters, in this regard we would like to inform that such NEC report from advocate has been uploaded on web portal.
