This is with reference to the above mentioned subject; we wish to submit as under for your kind consideration:

- 1. With reference to point 1 (one) of the said letter wherein it has been mentioned that Registration Certificate of the firm is uploaded in place of Brief details of enterprise. In this context we would like to submit that we have uploaded the LLP Agreement of "Excella Infrazone LLP". Further, the ITR for last 3 years have also been uploaded as it has been mentioned that it is not accessible.
- 2.
