With respect to other names appearing on the sanction maps i.e. **Smt. Sazda Begum, Mohd. Danish & KM Areeba**, we wish to submit that all the three above persons are not the land owners of the project, they are nowhere connected to the project in terms of development, ownership and financing, their names are appearing here only because they are "**shaamil khaatedaar**" in the revenue records. Promoter is in process to get the names removed in the records by submitting the partition deed at SDM Court but due to lockdown in the nation because of outbreak of Covid-19 pandemic the same updation is pending at their end.


Therefore it is to be noted that "AERA Constructions and Developers Private Limited" has the exclusive right to develop the project "**Royal Villas**".
