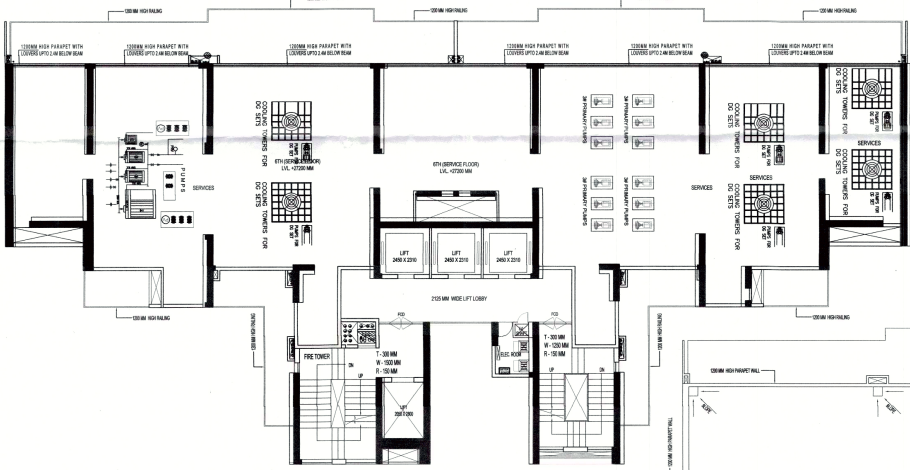




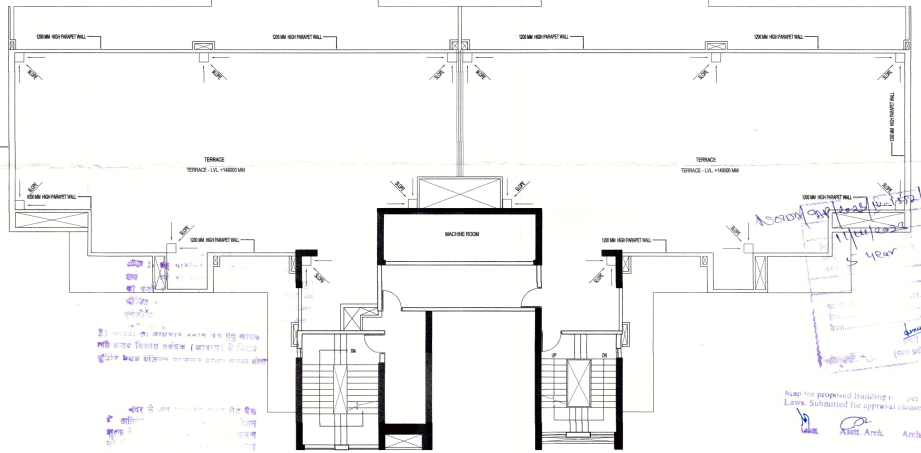
REFUGE FLOOR PLAN (15th, 24th, & 33rd)

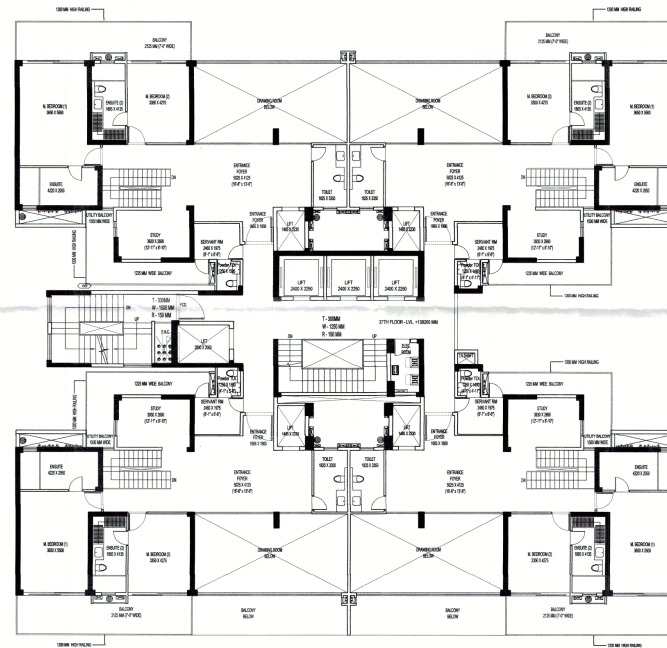
