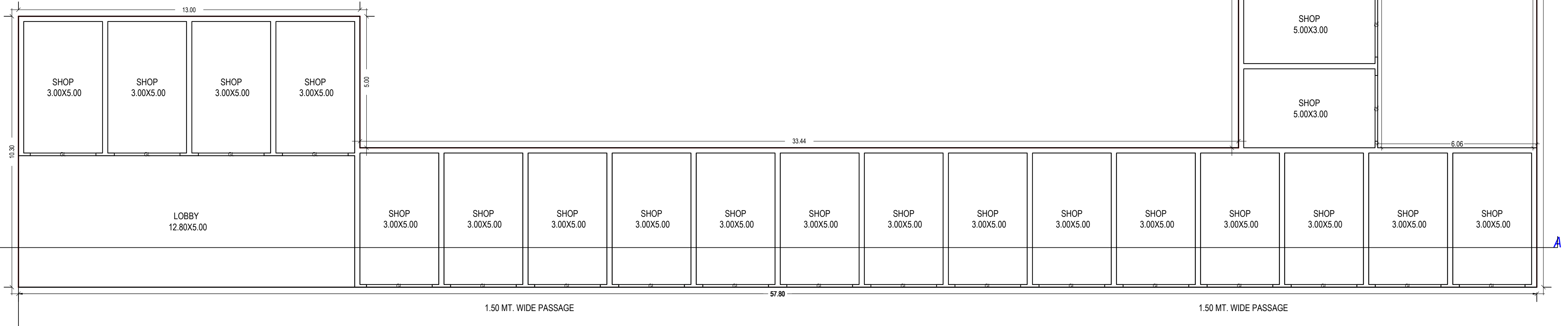
TERRACE FLOOR PLAN
