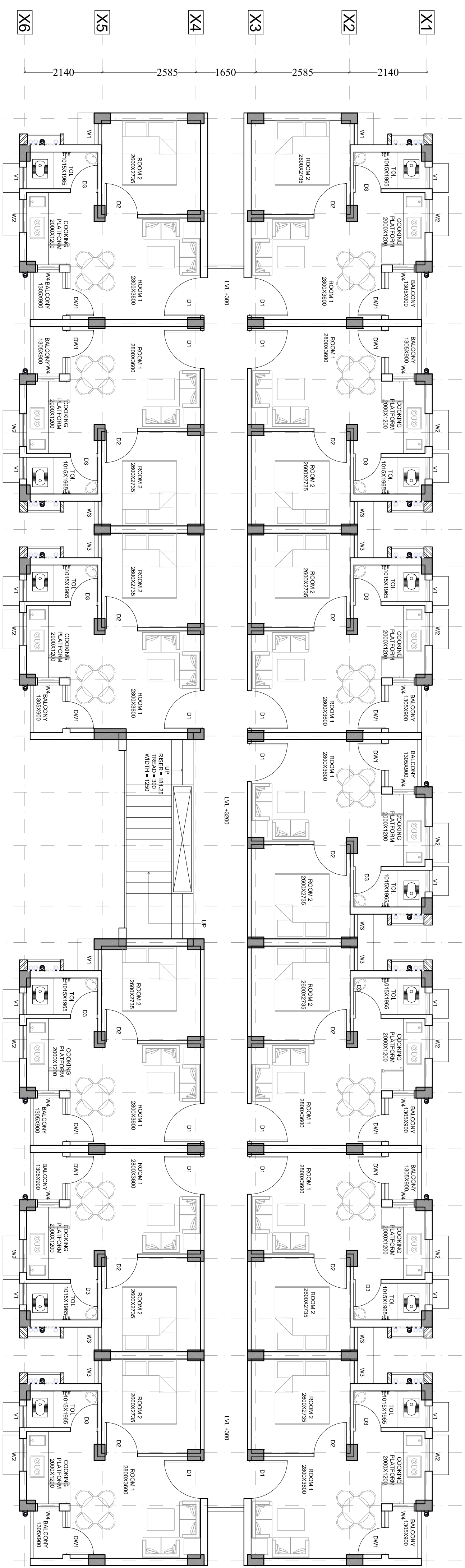


TERRACE FLOOR PLAN

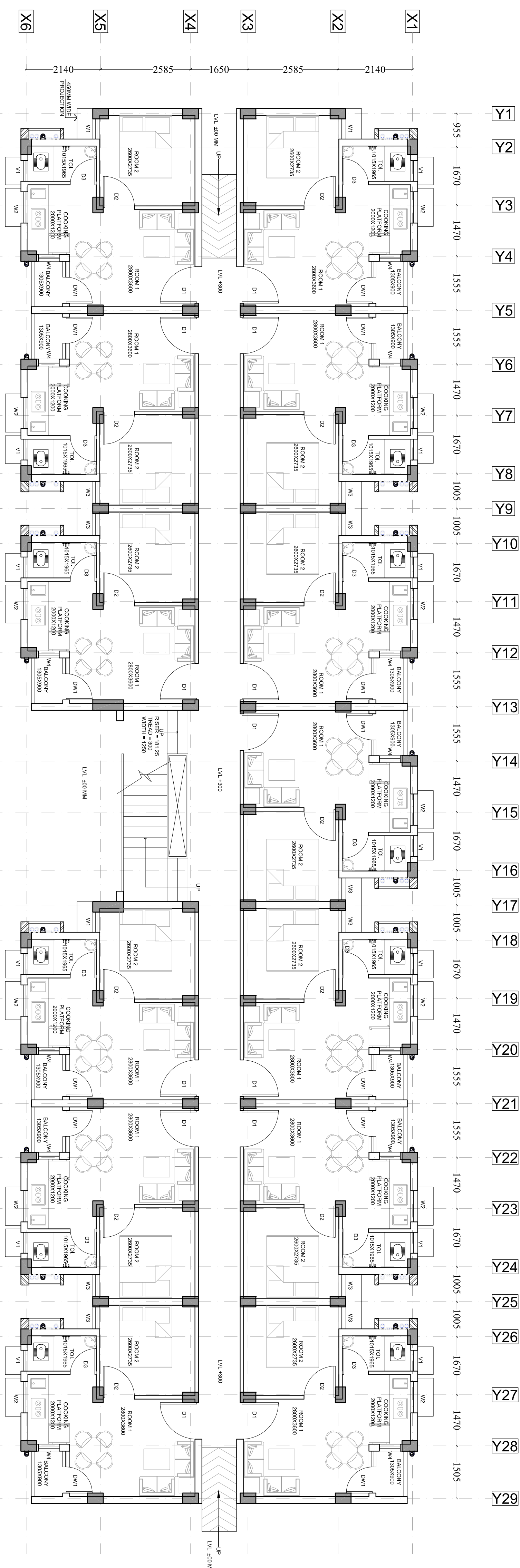

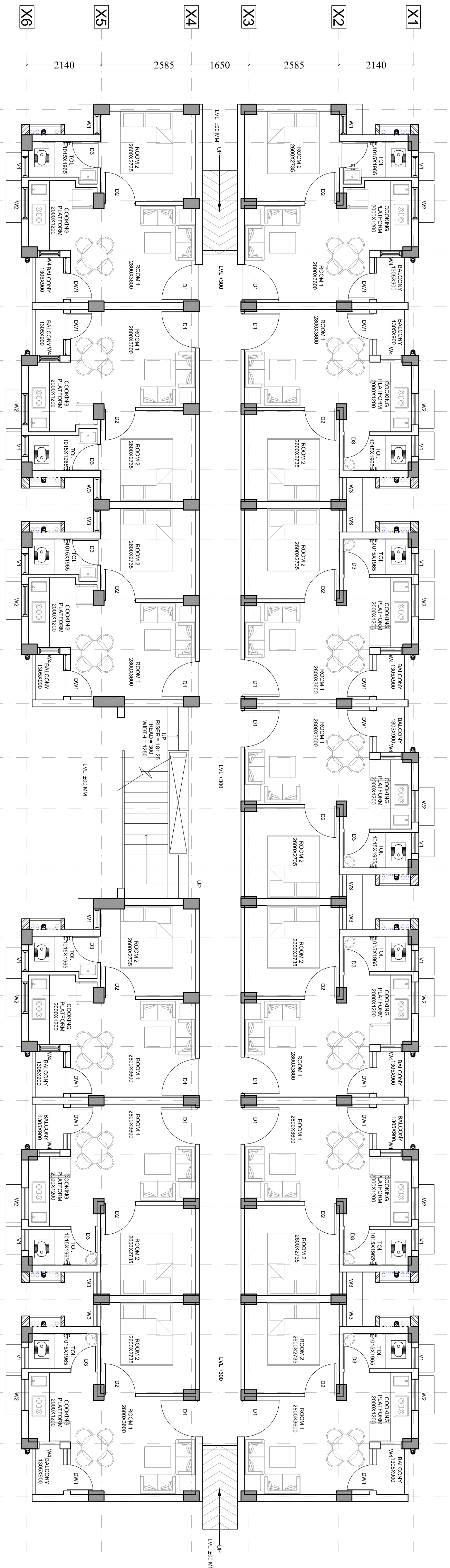


TERRACE FLOOR PLAN

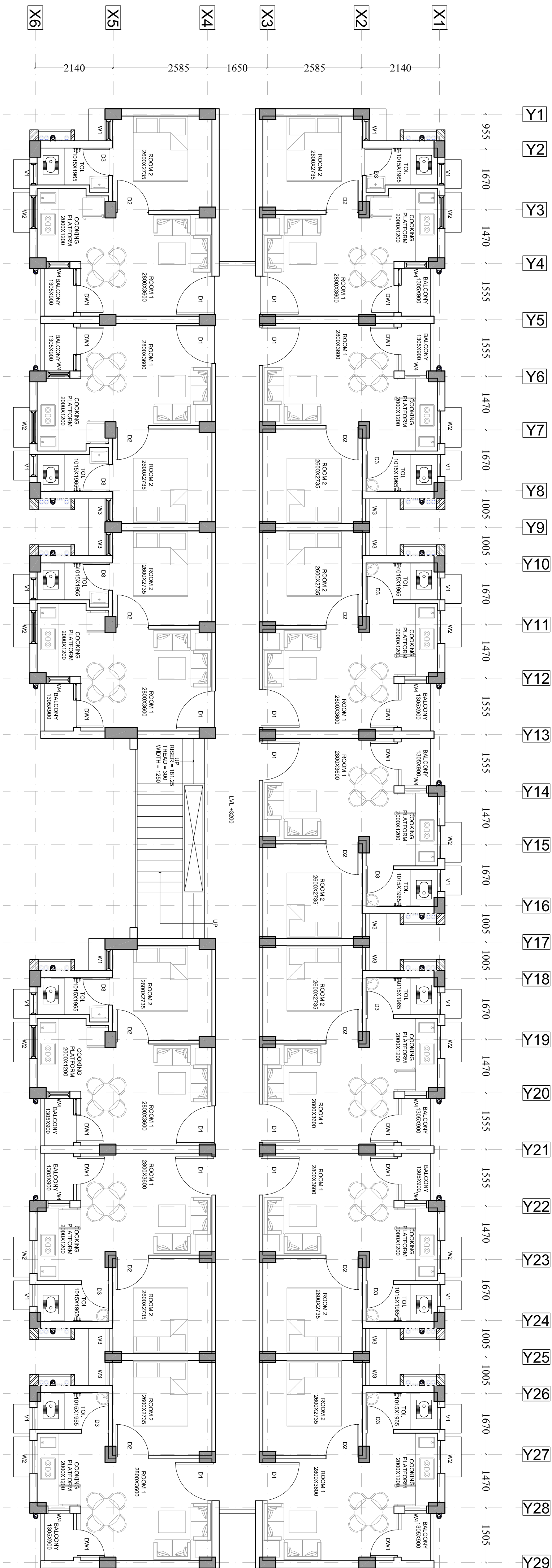


MUMTY ROOF FLOOR PLAN

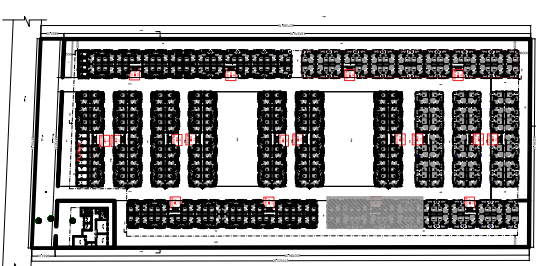

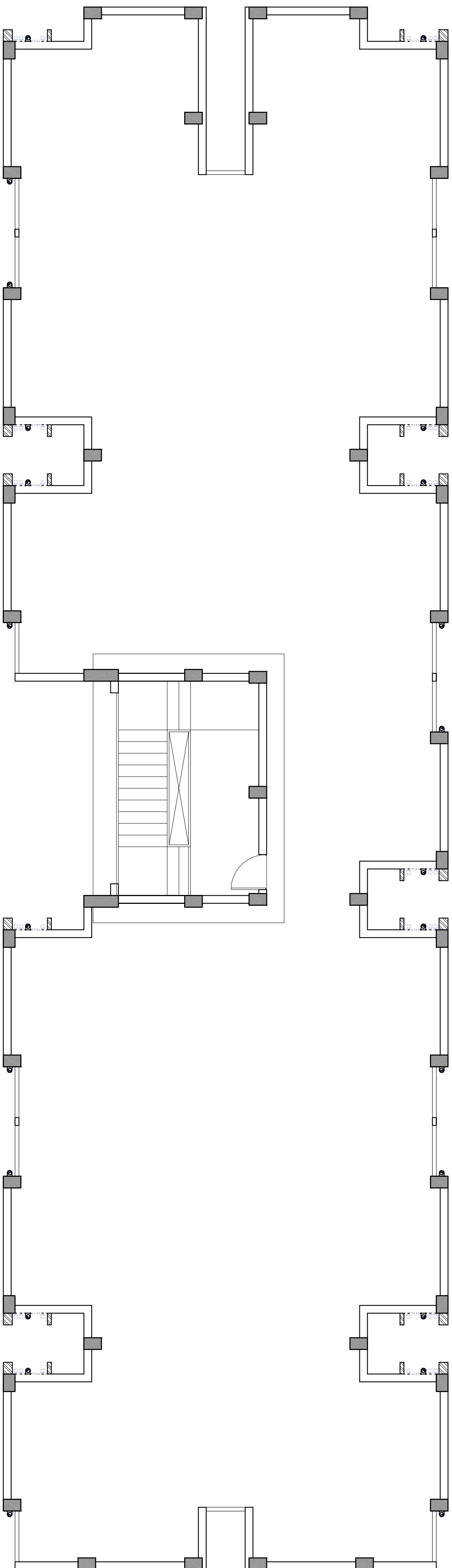

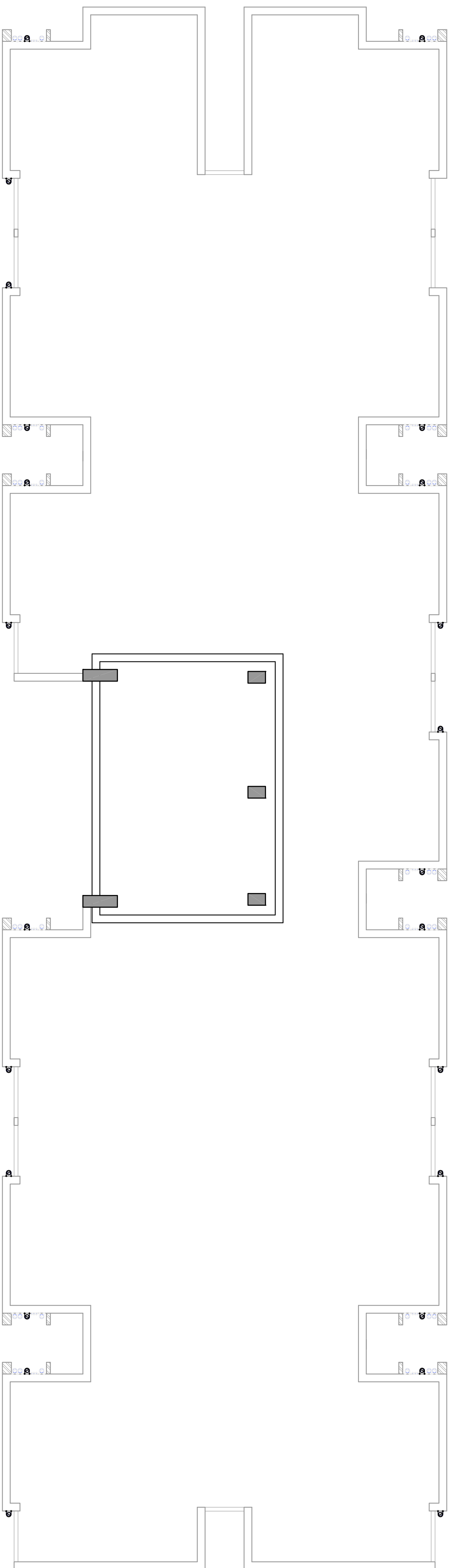
