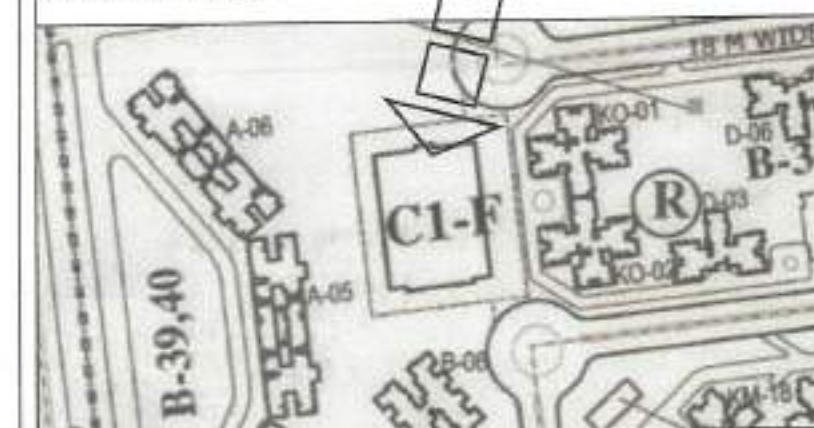

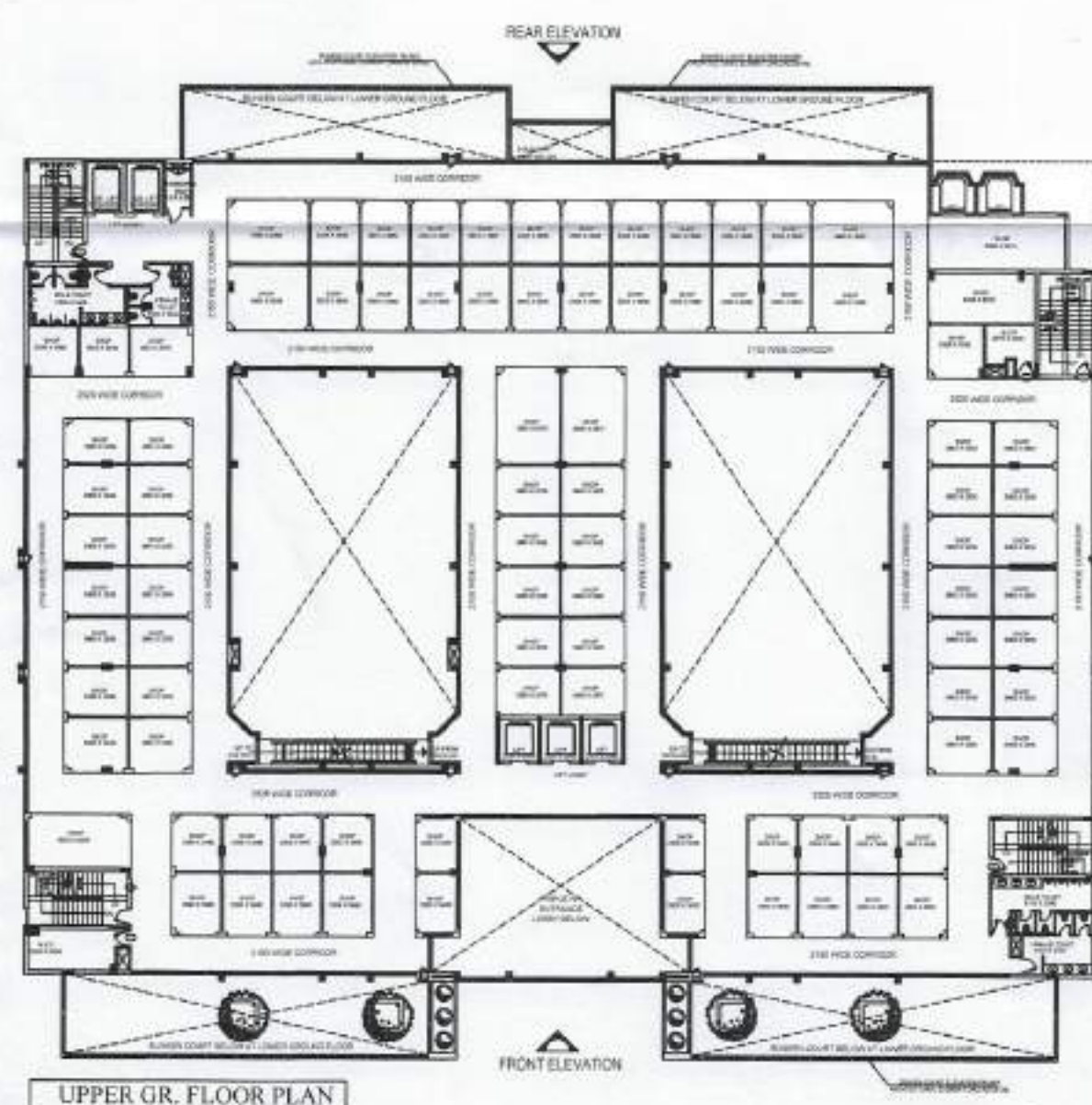

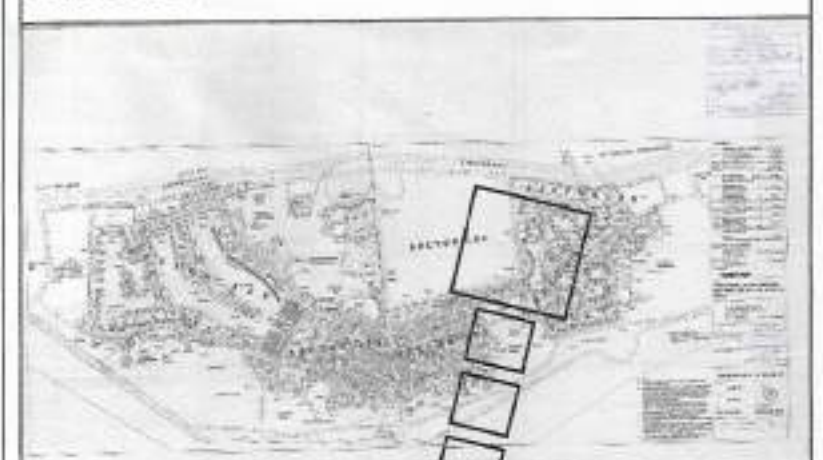
FRONT ELEVATION



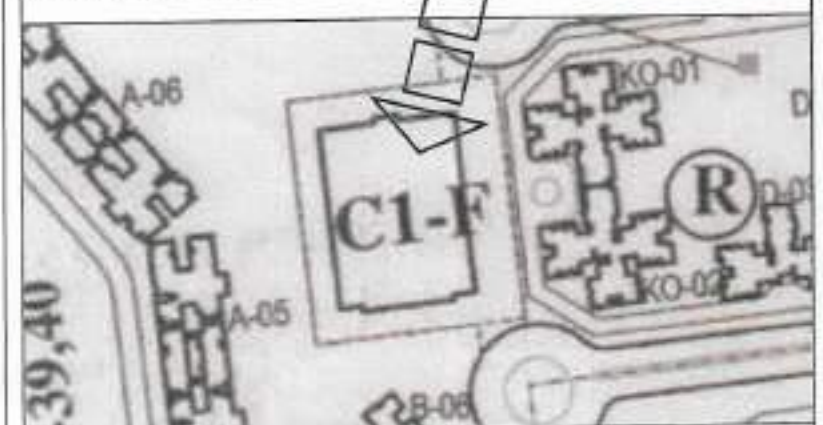
REAR ELEVATION
