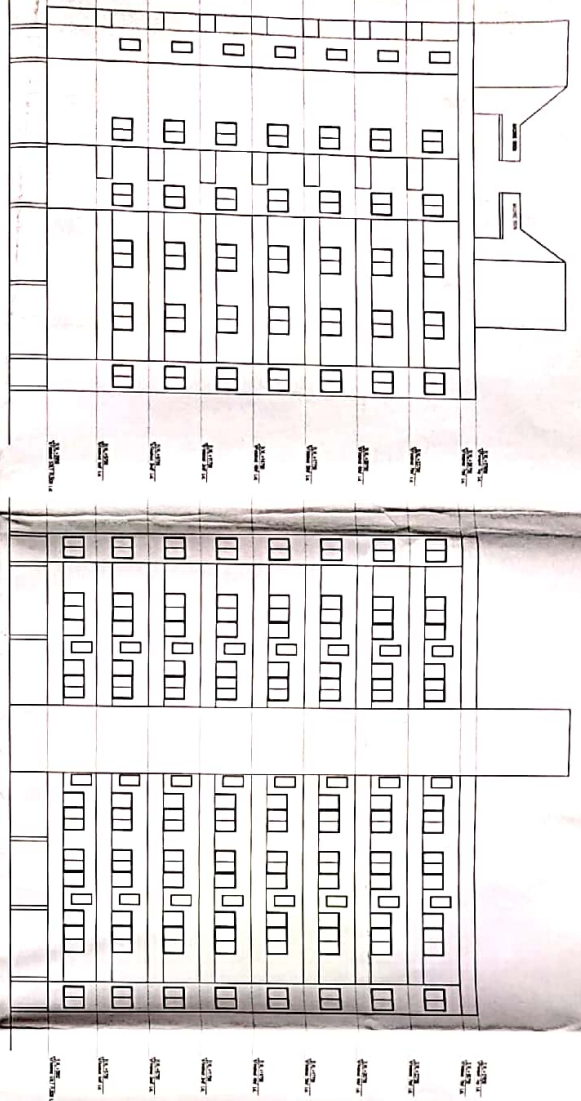

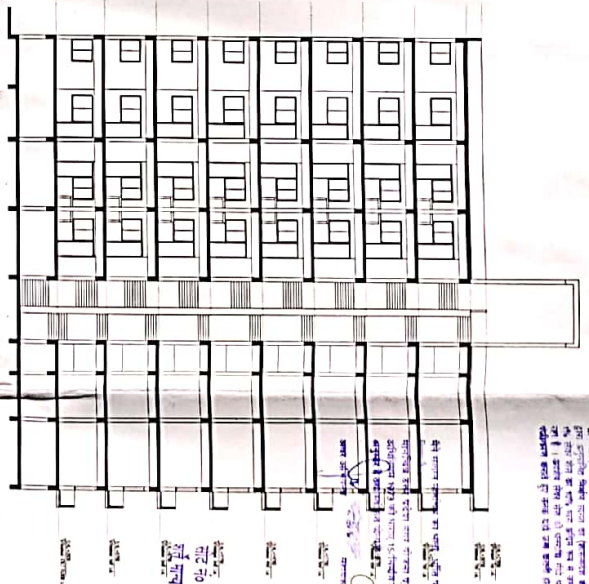

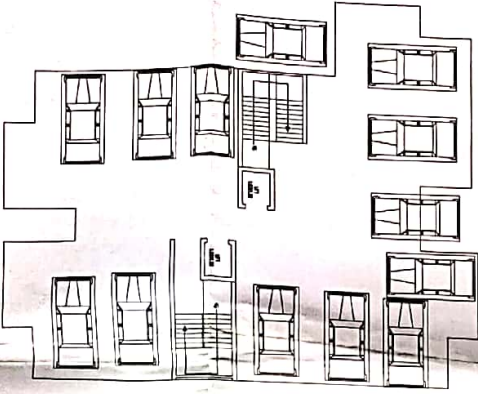


SIDE ELEVATION

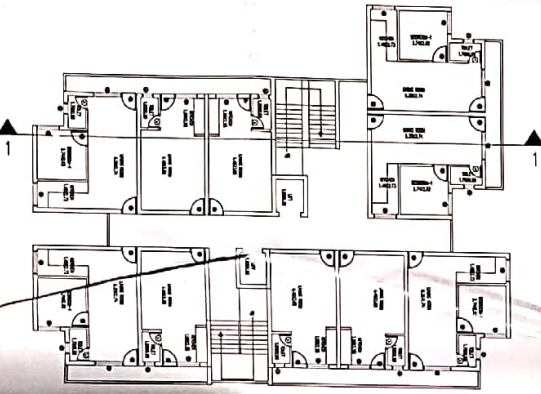

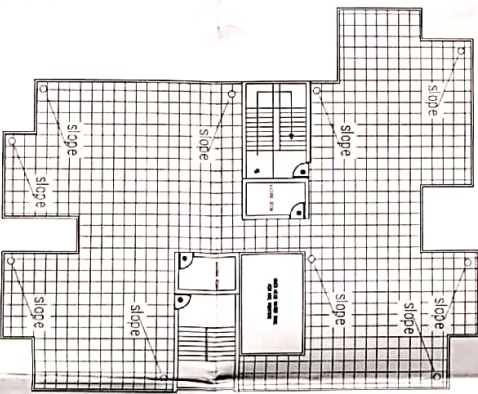
