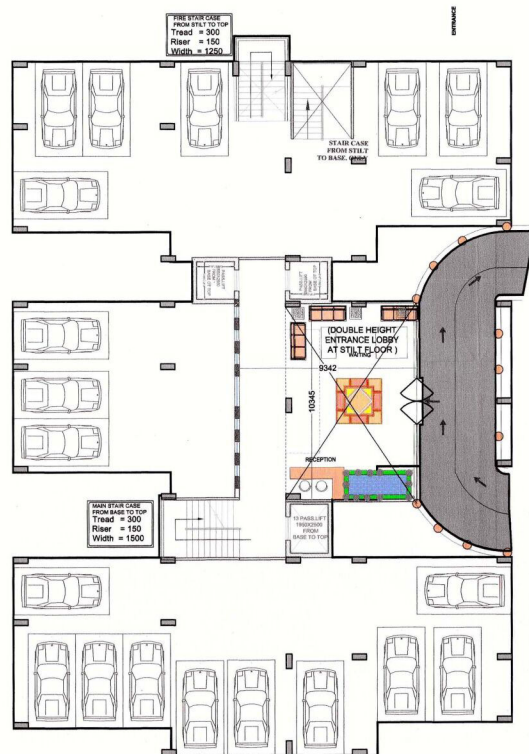


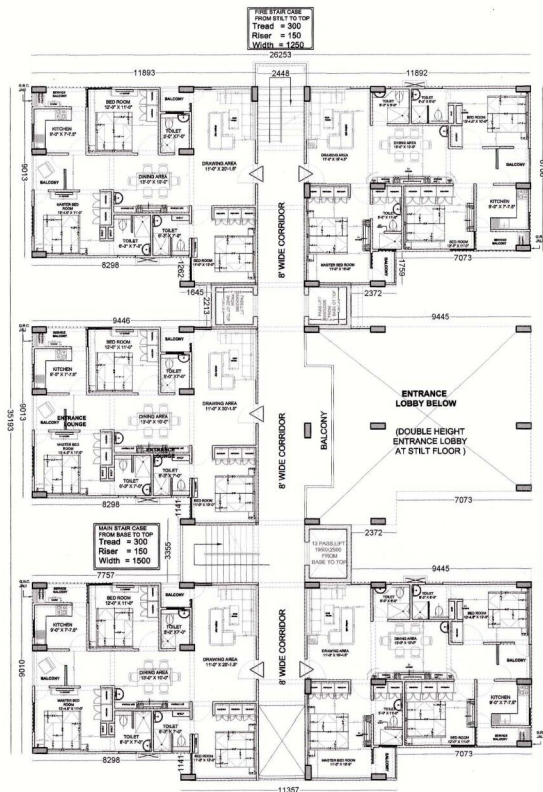

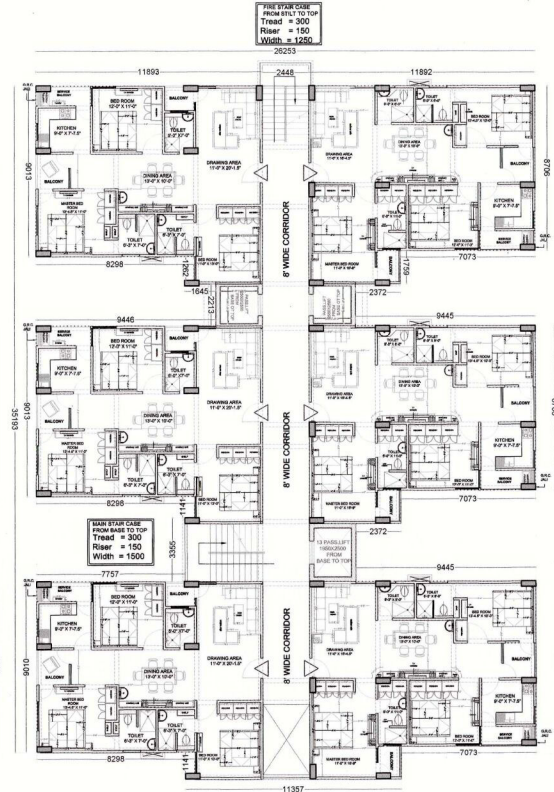
STILT FLOOR PLAN

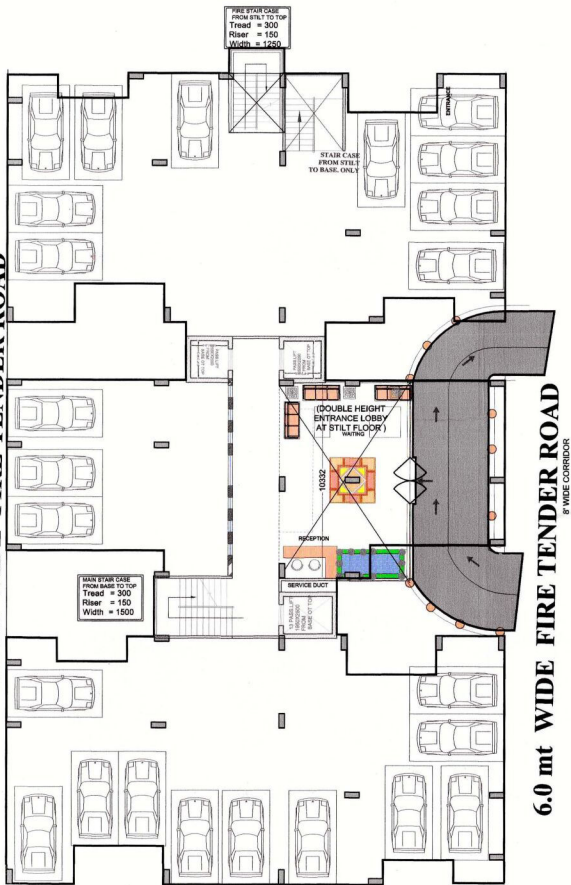

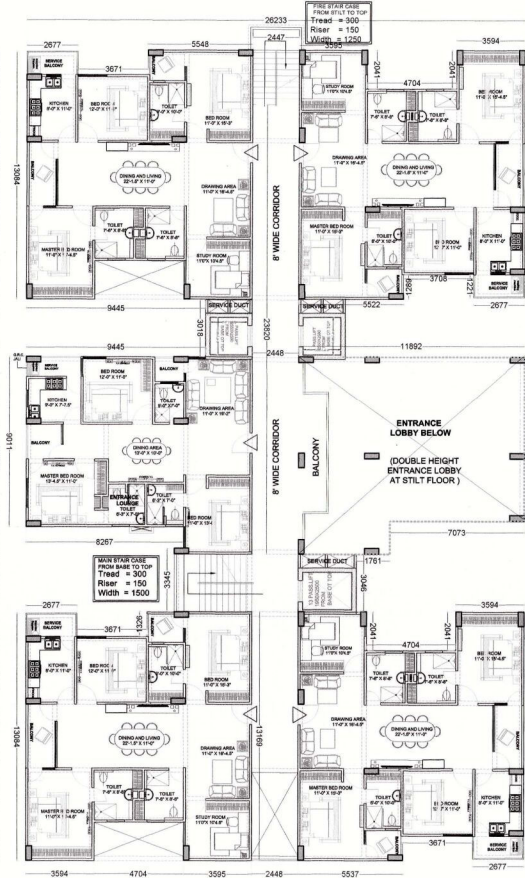

6.0 mt WIDE FIRE TENDER ROAD



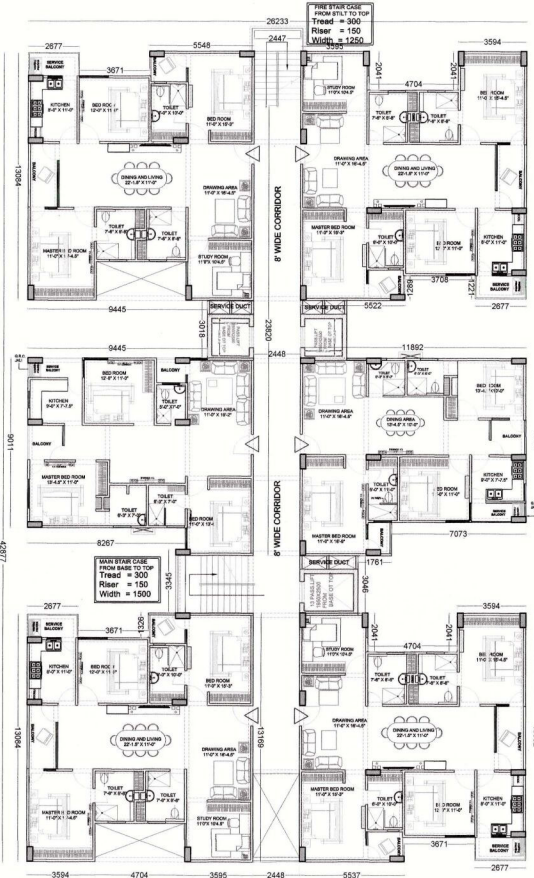
STILT FLOOR PLAN
