- If the applicant gets his registry done in the name of other person then in that case he'll pay the amount of Rs.1 lakhs to the developer as transfer charges.

- If applicant fails to get his registry done within the time mentioned in the agreement, then a notice period of 30days will be given to the applicant. If the applicant still fails then the Cancellation Clause will be applicable.
