I, Mohd. Khalid, Promoter of the proposed project Oasis Garden, do hereby solemnly declare, undertake and state as under:

- That promoter has a legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between other owners and promoter for development of the real estate project is being submitted.
- That the said land is free from all encumbrances.
- That the time period within which the project shall be completed by promoter is 31st December 2027
