

## FORM 'B' Affidavit cum Declaration

Affidavit cum Declaration of Mr. Pravesh Upadhyay S/o Shri Gopal Upadyay R/o 42/43, Asha Puram, Sanjay Nagar, Bareilly:

I, Mr. Pravesh Upadhyay S/o Shri Gopal Upadyay on behalf of the M/s Gajkesari Infra Developers, do hereby solemnly declare, undertake and state as under:

- M/s Gajkesari Infra Developers have a legal title to the land on which the

  authentication of title of such land along with an authenticated copy of
  arrangement between owners and M/s Gajkesari Infra Developers for
  development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by M/s Gajkesari Infra Developers is 5 years.
- 4. That seventy percent of the amounts realized by M/s Gajkesari Infra Developers for the real estate project from the allottees, from time to time, shall be deposited in separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 6. That the amounts from separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawals is in proportion to the percentage of completion of the project.
- 7. That M/s Gajkesari Infra Developers shall get the accounts audited within six months after the end of every financial year by a chartered accountants in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountants and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- That M/s Gajkesari Infra Developers shall take all the pending approvals on time, from the competent authorities.
- That M/s Gajkesari Infra Developers has furnished all documents as have been prescribed by the rules and regulations made under the act.
- 10. That M/s Gajkesari Infra Developers shall not discriminate against any allottee at the time of allotment of any plot, on any grounds.
- 11. That the project will get completed by 02-07-2026.
