1. That promoter has a legal title to the land on which the development of the proposed project is proposed




2. That details of encumbrances as per attachment including details of any rights, title, interest or name of any party in or oversuch land, along with details.

8. That promoter shall take all the pending approvals on time, from the competent authorities.

9. That promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.




