





I, Mr. Tika Singh Rawat, Authorized Signatory of Shridhara Infratech Private Limited (“Promoter”) do hereby solemnly declare, undertake and state as under:

- 1 That the promoter has a legal title to the land on which the development of the proposed project is to be carried out and an authenticated copy of the title of such land is enclosed herewith
2. That details of encumbrances as per attachment including details of any rights, title, interest or name of any party in or over such land, along with details are uploaded on to the URPERA website at the time of registration.
- 3 That the time period within which the project shall be completed by promoter is 84 months from the project start date.
- 4 That seventy per cent of the amounts realised by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5 That the amounts from the separate account to cover the cost of the Project, shall be withdrawn in proportion to the percentage of completion of the project.
- 6 That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7 That the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
