




I, Vikas Dua the above named the authorized signatory of the promoter company do hereby solemnly declare, undertake and state as under:

1. That the promoter company has legal title to the land on which the development of the ongoing project is already in progress.
2. That there is no encumbrance on the said project land.
3. That the time period within which the project shall be completed by the promoter is March, 2023.
4.
