Please refer to your application/letter dated 18-02-2013, 24-06-2013 & 05-018-2013 addressed to the Secretary, SEAC & Director, Directorate of Environment, Lucknow. The case was presented by the project proponent along with the project consultant M/s Grass Roots Research and Creations (P) Ltd.in the State Level Expert Appraisal Committee (SEAC) meeting held on 22-03-2013.

The Project proponent, through documents (submitted to SEAC) and presentation made during meeting, has informed to the SEAC that:-

- The Project proposal falls under category 8(a) of EIA Notification, 2006 (as amended) and will be located at Plot No HR-12A, Surajpur Site C, Greater Noida, G.B. Nagar, U.P.
- The total plot area and proposed built-up area of the project are respectively 10742 mt sq. and 45074.52 mt sq.
- Green belt area of the proposed project is 4054.50 mt sq i.e. 50.43 % of the total plot area.
- The total water requirement is proposed as 163 KLD from municipal supply. Total Fresh water requirement is proposed as 108 KLD.
- The total waste water generation is proposed as 132 KLD to be treated in STP of 160 KLD capacity.
- Total power requirement is proposed as 2389 KVA to be supplied by Uttar Pradesh Power Corporation Limited.
- 7. 2 No of DG Sets with capacity of 500 KVA are proposed for power backup.
- 8. Total no of proposed RWH pits are 2.
- Parking facility is proposed for 523 ECS.
- 10. Quantity of proposed MSW is 926 Kg/Day.
- 11. All internal roads are proposed to be at least 9 meter wide.

Based on the recommendations of the State Level Expert Appraisal Committee Meeting held on 22-03-2013 & 29-07-2013 the State Level Environment Impact Assessment Authority in its Meeting held on 20-09-2013 has decided to grant the Environmental Clearance to the project subject to the effective implementation of the following general and specific conditions:-

a. General Conditions:

 It shall be ensured that all standards related to ambient environmental quality and the emission/effluent standards as prescribed by the MoEF are strictly complied with.

- 16. Make separate provision for the temporary storage of two days for MSW and E-
- 17. All the Environmental Issues are to be taken care of before occupancy of dwellings. This Environmental Clearance is subject to ownership of the site by the project proponents in confirmation with approved Master Plan for Greater Noida. In case of violation, it would not be effective and would automatically be stand cancelled.

You are also directed to ensure that the proposed site is not a part of any nodevelopment zone as required/prescribed/identified under law. In case of violation, this permission shall automatically deem to be cancelled. Also, in the event of any dispute on ownership or land use of the proposed site, this clearance shall automatically deemed to be

The project proponent will have to submit approved plans and proposals incorporating the conditions specified in the Environmental Clearance within 03 months of issue of the clearance. The SEIAA/MoEF reserves the right to revoke the environmental clearance, if conditions stipulated are not implemented to the satisfaction of SEIAA/MoEF. SEIAA may impose additional environmental conditions or modify the existing ones, if necessary. Necessary statutory clearances should be obtained and submitted before start of

These stipulations would be enforced among others under the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006 including the amendments and rules made thereafter.

This is to request you to take further necessary action in the matter as per provision of Gazette Notification No. S.O. 1533(E) dated 14.9.2006, as amended and send regular compliance reports to the authority as prescribed in the aforesaid notification.

(O. P. Varma) Secretary, SEAC/ Director (I/C), Environment water. Fully impermeable pavements shall not be constructed. Construction of pavements around trees shall be as per scientifically accepted principles in order to provide suitable watering, aeration and nutrition to the tree.

The Green building Concept suggested by Indian Green Building Council, which is a 24. part of CII-Godrej GBC, shall be studied and followed as for as possible.

Compliance with the safety procedures, norms and guidelines as outlined in National 25. Building Code 2005 shall be compulsorily ensured.

- Ensure usage of dual flush systems for flush cisterns and explore options to use 26. sensor based fixtures, waterless urinals and other water saving techniques.
- Explore options for use of dual pipe plumbing for use of water with different qualities 27. such as municipal supply, recycled water, ground water etc.
- Ensure use of measures for reducing water demand for landscaping and using 28. xeriscaping, efficient irrigation equipments & controlled watering systems.
- Make suitable provisions for using solar energy as alternative source of energy. Solar 29. energy application should be incorporated for illumination of common areas, lighting for gardens and street lighting in addition to provision for solar water heating. Present a detailed report showing how much percentage of backup power for institution can be provided through solar energy so that use and polluting effects of DG sets can be minimized.
- Make separate provision for segregation, collection, transport and disposal of e-30.
- Educate citizens and other stake-holders by putting up hoardings at different places 31. to create environmental awareness.
- Traffic congestion near the entry and exit points from the roads adjoining the 32. proposed project site must be avoided. Parking should be fully internalized and no public space should be utilized.
- Prepare and present disaster management plan. 33.
- A report on the energy conservation measures confirming to energy conservation 34. norms finalize by Bureau of Energy efficiency should be prepared incorporating details about building materials and technology, R & U Factors etc.
- Fly ash should be used as building material in the construction as per the provision of 35. fly ash notification of September, 1999 and amended as on August, 2003 (The above condition is applicable only if the project lies within 100 km of Thermal Power Station).
- 36. The DG sets to be used during construction phase should use low sulphur diesel type and should conform to E.P. rules prescribed for air and noise emission standards.
- 37. Alternate technologies to Chlorination (for disinfection of waste water) including methods like Ultra Violet radiation, Ozonation etc. shall be examined and a report submitted with justification for selected technology.
- 38. The green belt design along the periphery of the plot shall achieve attenuation factor conforming to the day and night noise standards prescribed for residential land use. The open spaces inside the plot should be suitably landscaped and covered with vegetation of indigenous variety.
- The construction of the building and the consequent increased traffic load should be 39. such that the micro climate of the area is not adversely affected.
- 40. The building should be designed so as to take sufficient safeguards regarding seismic zone sensitivity.
- High rise buildings should obtain clearance from aviation department of concerned 41. authority.
- 42. Suitable measures shall be taken to restrain the development of small commercial activities or slums in the vicinity of the complex. All commercial activities should be restricted to special areas earmarked for the purpose.

- It is suggested that literacy program for weaker sections of society/women/adults (including domestic help) and under privileged children could be provided in a formal
- The use of Compact Fluorescent lamps should be encouraged. A management plan 44. for the safe disposal of used/damaged CFLs should be submitted.
- It shall be ensured that all Street and park lighting is solar powered. 50% of the same 45. may be provided with dual (solar/electrical) alternatives. 46.
- Solar water heater shall be installed to the maximum possible capacity. Plans may be drawn up accordingly ad submitted with justification.
- Treated effluents shall be maximally reused to aim for zero discharge. Where ever 47. not possible, a detailed management plan for disposal should be provided with quantities and quality of waste water. 48.
- The treated effluents should normally not be discharged into public sewers with terminal treatment facilities as they adversely affect the hydraulic capacity of STP. If unable, necessary permission from authorities should be taken.
- Construction activities including movements of vehicles should be so managed so 49. that no disturbance is caused to nearby residents.
- All necessary statutory clearances should be obtained and submitted before start of 50. any construction activity and if this condition is violated the clearance, if and when given, shall be automatically deemed to have been cancelled.

- Specific location along with dimensions with reference to STP, Parking, Open areas 56. and Green belt etc. should be provided on the layout plan. 57.
- The DG sets shall be so installed so as to conform to prescribed stack heights and regulations and also to the noise standards as prescribed. Details should be submitted.
- E-Waste Management should be done as per MoEF guidelines. 58.
- Electrical waste should be segregated and disposed suitably as not to impose 59. Environmental Risk. 60.
- The use of suitably processed plastic waste in the construction of roads should be 61.
- Displaced persons shall be suitably rehabilitated as per prescribed norms.
- Dispensary for first aid shall be provided. 62.
- Safe disposal arrangement of used toiletries items in Hotels should be ensured. 63. Toiletries items could be given complementary to guests, adopting suitable
- Diesel generating set stacks should be monitored for CO and HC. 64.
- Ground Water downstream of Rain Water Harvesting pit nearest to STP should be monitored for bacterial contamination. Necessary Hand Pumps should be provided for sampling. The monitoring is to be done both in pre and post monsoon, seasons.

- A Separate electric meter shall be provided to monitor consumption of energy for the 67. operation of sewage/effluent treatment in tanks.
- An energy audit should be annually carried out during the operational phase and 68. submitted to the authority.
- Project proponents shall endeavor to obtain ISO: 14001certification. All general and 69. specific conditions mentioned under this environmental clearance should be included in the environmental manual to be prepared for the certification purposes and compliance.
- 70. Appropriate safety measures should be made for accidental fire.
- Smoke meters should be installed as warning measures for accidental fires. 71.
- Project falling with in 10 Km. area of Wild Life Sanctuary is to obtain a clearance from 72. National Board Wild Life (NBWL) even if the eco-sensitive zone is not earmarked.

b. Specific Conditions:

- 1. Sprinkler to be used for curing and quenching during construction phase.
- 2. STP to be constructed during construction phase.
- 3. For the treatment for total sewage a full-fledged STP is to be provided during opreation phase.100% waste water is to be treated in captive STP conforming to prescribed standards of receiving body for designated use. Monitoring of STP to be done weekly till its stabilizations.
- 4. Prior discharge of excess treated waste water into public drainage system permission from the competent authority is to be taken.
- 5. Dedicated power supply for STPs is to be ensured. During operation sludge of STP is to be used in house and surplus manure should be managed by giving to end users.
- 6. All entry/exit point should be bell mouth shaped. All internal roads should not be less than 9 meter wide:
- 7. Wheel wash arrangement is to be made at exit point during construction phase.
- 8. Use of LEDs should be explored in place of CFL. Solar light is to be provided in the common areas with 50% of them may be with dual provision.
- 9. 100 % provision of Rain Water Harvesting is to be made. RWH shall be initially done only from the roof top. RWH from green and other open areas shall be done only after permission from CGWB.
- 10. Height of the stack should be provided as discussed based on combined DG sets capacity and be 6mt higher than the tallest building.
- 11. Environmental Corporate Responsibility (ECR) plan along with budgetary provision amounting to 2% of total project cost shall be submitted (within the month) on need base assessment study in the study area. Income generating measures which can help in up-liftment of weaker section of society consistent with the traditional skills of the people identified. The program me can include activities such as old age homes, rain water harvesting provisions in nearby areas, development of fodder farm, fruit bearing orchards, vocational training etc. In addition, vocational training for individuals shall be imparted so that poor section of society can take up self employment and jobs. Separate budget for community development activities and income generating programmers shall be specified.
- 12. Crèche, convenient shopping provision is to be provided during construction and the
- 13. A dedicated space/room for senior citizens at club/recreation hall with suitable facilities shall be provided during the operation phase.
- 14. Green cover should be as per CPCB norms.
- 15. The project proponent will submit the management plan of excavated soil within three months from the date of receipt of the E.C. letter.

- It shall be ensured that obtain the no objection certificate from the U P pollution 2.
- It shall be ensured that no construction work or preparation of land by the project 3. management except for securing the land is started on the project or the activity without the prior environmental clearance.
- The proposed land use shall be in accordance to the prescribed land use. A land use certificate issued by the competent Authority shall be obtained in this regards.
- All trees felling in the project area shall be as permitted by the forest department under the prescribed rules. Suitable clearance in this regard shall be obtained from the competent Authority.
- Impact of drainage pattern on environment should be provided. 6. 7.
- Surface hydrology and water regime of the project area within 10 km should be 8.
- A suitable plan for providing shelter, light and fuel, water and waste disposal for construction labour during the construction phase shall be provided along with the
- Measures shall be undertaken to recycle and reuse treated effluents for horticulture 9: and plantation. A suitable plan for waste water recycling shall be submitted. 10.
