6. A copy of the sanction drawing shall always be kept at site and shall be made available to any officer of the Authority on demand.

You shall be responsible for carrying out the work in accordance with the requirements of Greater Noida Industrial Development Building Regulation 2005. and direction made form time to time.

Prior permission is required before digging an under ground bore well.

10. No activity other than as specified in lease deed shall be permitted in the premises

- 11. Prior permission is permission from the Authority is required for temporary structure also like labour huts &
- 12. Gate shall open on to the service road only. Direct access to the main carriageway shall not be provided.

13. Services, rain water harvesting shall be laid as per approval of Authority.

14. No parking of any kind shall be permitted on r/w of road.

15. Pejometer shall have to be installed as per direction issued by Authority.

- 16. Complying with all the requirement for obtaining NOC from various departments prior to submission of application for occupancy shall be the responsibility of allottee irrespective of the proposal sanctioned by

Before starting construction, the NOC is required from Ministry of Environment & Forest under notification no-60(A) dated 27-1-1994 and its amendment from time to time or under notification dated 14-09-2006 which ever is applicable. The copy of shall be submitted to the Authority. If construction is started before obtaining the NOC, the sanction shall be treated as cancelled.


