Standard obstruction lightings as per IS 5613 notification and International Civil Aviation Organization (ICAO) standards as stipulated in ICAO-Annex-14 is to be provided by the company. The lights should be switched 'ON' at all times. Provision shall be made for standby power supply to keep the lights 'ON' during power failure.

- (c) Periodic maintenance of obstruction lightings to be carried out by the company at regular intervals to keep them in serviceable and visible condition.
- (d) Closed garbage containers shall be used in the building complex in order to avoid bird activity.
- (e) No light or a combination of lights which by reason of its intensity, configuration or colour may cause confusion with aeronautical ground lights of an airport shall be installed at the site at any time during or after construction of the building.
- (f) The commencement, completion of works, inclusive of installation of obstruction lights are to be intimated to AOC, AF Station Hindan and HQ WAC, AF, CATCO, Subroto Park, New Delhi. Failure to render these certificates within the stipulated time shall lead to cancellation of NOC.
- (g) The validity of this NOC is five years from the date of issue.
