1. Terms:

	3.2	The Promoter and Co-Promoters accepts no responsibility in regard to matters specified in Para3.1 above. The Allottee shall keep the Promoter and Co-Promoters fully indemnified and harmless in this regard. Whenever there is any change in the residential status of the Allottee subsequent to the signing of this Agreement, ii shall be the sole responsibility of the Allottee to intimate the same in writing to the Promoter and Co-Promoters immediately and comply with necessary formalities, if any, under the applicable laws. 6	CONSTRUCTION OF THE PROJECT / APARTMENT:	
		The Allottee has seen the proposed layout plan, specifications, amenities and facilities of the Plot and accepted the payment plan and the specifications, amenities and facilities [annexed along with this Agreement] which has been approved by the competent authority, as represented by the Promoter. The Promoter shall develop the Project in accordance with the said layout plans and specifications, amenities and facilities. 7	POSSESSION OF THE APARTMENT/PLOT:	
	7.1	Schedule for possession of the said Plot- The Promoter agrees and understands that timely delivery of possession of the Plot to the Allottee and the Common Areas to the association of Allottees or the competent authority, as the case may be, is the essence of the Agreement. The Promoter and Co-Promoters assures to hand over possession of the Plot along with

	<p>ready and complete Common Areas with all specifications, amenities and facilities of the Project in place on _____, unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project ("Force Majeure"). If, however, the Completion of the Project is delayed due to the Force Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the Plot:</p> <p>Provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. The Allottee agrees and confirms that, in the event it becomes impossible for the Promoter to implement the project due to Force Majeure conditions, then this allotment shall stand terminated and the Promoter shall refund to the Allottee the entire amount received by the Promoter from the allotment within 120days from that date. The Promoter and Co-Promoters shall intimate the Allottee about such termination at least thirty days prior to such termination. 	(i)	The [Promoter and Co-Promoters] has absolute, clear and marketable title with respect to the said Land; the requisite rights to carry out development upon the said Land and absolute, actual, physical and legal possession of the said Land for the Project;
	(ii)	The Promoter and Co-Promoters has law full rights and requisite approvals from the competent Authorities to carryout development of the Project;
	(iii)	There are no encumbrances upon the said Land or the Project; [in case there are any encumbrances on the land provide details of such encumbrances including any rights, title, interest and name of party in or over such land]
	(iv)	There are no litigations pending before any Court of law or Authority with respect to the said Land, Project or the Plot;

	(v)	All approvals, licenses and permits issued by the competent authorities with respect to the Project, said Land and Plot are valid and subsisting and have been obtained by following due process of law. Further, the Promoter has been and shall, at all times, remain to be in compliance with all Applicable Law in relation to the Project, said Land, Building and Plot and Common Areas;
	(vi)	The Promoter and Co-Promoters has the right to enter into this Agreement and has not committed or omitted to perform any act or thing, where by the right, title and interest of the Allottee created herein, may prejudicially be affected;
