



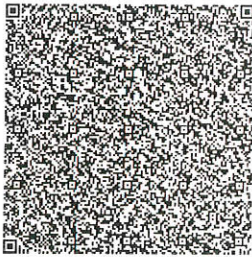

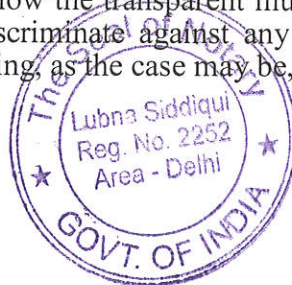

1. That **M/s. Fourleaf Developers Private Limited** has a legal title to the land on which the development of the project is proposed

2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by promoter is **78** months.
4. That seventy per cent of the amounts realised by Promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That Promoter has obtained the statutory NOC and shall complete all the statutory requirements of obtaining the rest of NOC's for approval of the project and shall submit the same to competent authority for approval on time.
9. That Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
10. That Promoter shall follow the transparent mutually agreed policies with concurrence of the allottee and not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
