INSTRUCTIONS

Before submitting the application form, the following terms and condition should be read carefully, this is legally binding on the Applicant.

Terms & Condition for submitting Application Form:

- 01. Within 1 month from application date, the applicant shall have to deposit 10% of the total cost to get the provisional allotment of Unit done in his/her name and balance amount as per schedule.
- 02. The cost of unit does not include water connection, electric connection, cable T.V. or DTH Connection.
- 03. If the applicant fails to deposit the allotment amount within the stipulated period, the builder (S V BUILDERS & PROMOTERS) has the right to cancel the allotment and refund the deposited amount after deducting 10% of the total cost.
- 04. The cost of unit does not include any government charges such as GST, Service tax, Trade tax, Stamp duty for registration, municipal taxes and electric charges etc. which are extra and are to be borne by the allottee.
- 05.
