- 3. The applicant (s) have inspected the location of the project and having satisfied with the location, signed and submitted this application to vxl for booking the villa unit. The applicant has also read & understood the details & specifications of the project contained in the Brochures provided by vxl.
- 4. The applicant(s) agree to execute the agreement for sale for villa /unit in vxl's standard format within stipulated period of 30 days as the case may be from the date of this application .failure to execute agreement for sale within the prescribed period as above, the applicant(s) the vxl will also have every right to change the completion date/compensation dates as per revised dates.
