Sir,

I am directed to refer to your letter dated 05.10.2009 on the above subject and to say that Air HQ has no objection from aviation angle for construction of multi-storied buildings for residential project at Village Kanauni, Ahinsa Khand II, Indrapuram, Ghaziabad by M/s SVP Builders (I) Ltd, subject to the following conditions:-

- a) Height of the buildings shall not exceed 75 meters.
- b) Standard obstruction lightings to be provided by the company. The lights shall be switched on during night and poor visibility.
- c) Periodic maintenance of obstruction lightings is to be carried out by the company/housing society/tenants at regular intervals to keep them in visible/serviceable condition.
- d) A garbage treatment plant shall be installed prior to the construction of buildings for the purpose of avoiding bird activity. The plant shall be shown to the AOC/his nominated representative at AF Stn Hindon on installation.
- e) The commencement, completion of works and installation of obstruction lights shall be intimated to AOC, AF Stn Hindon.
- f) Required security clearance should be obtained through MHA/IB of the Foreign Nationals/Indian representative employed/to be employed by the company in India.

2. You are also requested to obtain No Objection from other concerned Government Organization/Agencies as required.
