- g) I/we agree that if there should be any variation in the area of the commercial space available at the time of allotment, then in such case the payment or the excess/shortfall in area shall be paid / refunded, as the case may be proportionately at the same rate as agreed herein.

h) I/we agree that in the event of the default in making the payment of any installment (s) amount by me, as demanded by the Company or according to any of the order terms and conditions agreed herein, the Company shall have all rights to cancel my booking/ Provisional Registration at any stage and also shall have right to forfeit 15 % of the total value of the commercial apace booked by me from the actual amount paid by me, against the liquidity damages.
