 - 8. That I / promoter shall take all the pending approvals on time, from the competent authorities.
 - 9. That I / promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
 - 10. That I / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be on any grounds.
