



AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr. Mohan Singh Rawat, Director of the Eldeco Infrabuild Ltd. ("Promoter") of the proposed project.

I, Mohan Singh Rawat, Director of the Promoter, whose registered office is situated at 201-212, 2nd Floor, Splendor Forum, Jasola District Centre, New Delhi 110025, which is developing a proposed commercial project on a land admeasuring 6384 sq. mt. namely "Eldeco Saksham (EWS) and Eldeco Sukriti (LIG)" situated at Village Piparia (Ghanghora), Nainital Road, Bareilly, Uttar Pradesh ("Project") hereby solemnly declare, undertake and state as under:

1. That the Promoter by virtue of Consortium Agreement dated 17.05.2019 with the owners of the land of the proposed Project is entitled to carry out development of the proposed Project and has a legal valid authentication of the proposed Project is to be carried out.
2. That the said land of the proposed Project along with its receivables is now mortgaged to JM Financial Credit Solutions Limited for the purpose of raising finance.
3. That the time period within which the Project shall be completed by the Promoter is **21st October, 2026**.
4. That seventy percent of the amounts realised by Promoter for the Project from the allottees, from time to time, shall be deposited in a separate account to maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only that purpose.

That Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
8. That Promoter shall take all the pending approvals on time, from the competent authorities.
9. That Promoter have/has furnished such other documents as have been prescribed by the Rules and regulations made under the Act.
10. That Promoter shall not discriminate against any allottee at time of allotment of any apartment, plot or building; as such case may be, on any grounds.


