1. That I/We has/have not relied upon nor is influenced by any Architect's plans, advertisements, representations, warranties, statements or estimates of any nature whatsoever, whether written or oral made by Company or by any selling agents/brokers or otherwise including but not limited to any representations relating to the description of physical condition of the project site. The drawings/plans displayed in office of the Company showing the proposed Project (hereinafter referred to as 'the Project') is provisional and tentative. The Company can carry out such additions, alteration or deletions by any competent authority while sanctioning the building plan or at any time for the betterment of the project without any objection by me/us.
2. All payment shall be made through Demand drafts/Cheques/NEFT/RTGS etc. in favour of M/S PROMINENT DEVELOPERS or its special purpose company or its subsidiary as the case may be. All payments should be deposited only at the office of the Company. Company shall not be responsible/accountable for any payment made to agent/broker/any third person. It is only after I/we will sign and execute the Buyer's Agreement, Addendum to the Buyer's Agreement, and/or such other documents as may be required by the Company (depending on the options availed), the Allotment shall become final and binding upon the Company. 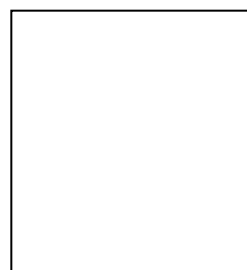

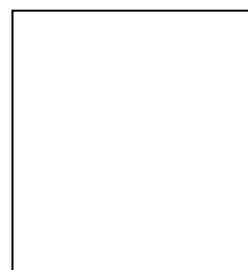
