The SEAC discussed the matter in its meeting dated 18/6/2016 and verified from the record and decided to incorporate the above changes in the 182nd SEAC minutes of meeting dated 20.6.2014 and environmental clearance letter no 1002/Parya/SEAC/2084/2013/ JDCA(S), Dated 07-08-2014 has to be revised and reissued. The SEAC recommendation dated 18/62016 regarding the matter was considered in the SEIAA meeting dated 18/7/2016 and the SEIAA agreed with the recommendations of the SEAC to incorporate the changes in the environmental clearance letter no 1002/Parya/SEAC/2084/2013/ JDCA(S), Dated 07-08-2014.

In this regard the changes, approved by the SEAC /SEIAA as above, are incorporated by revising and replacing them in the environmental clearance letter no 1002/Parya/SEAC/2084/2013/ JDCA(S), Dated 07-08- 2014.
