PROJECT MANAGEMENT STRUCTURE AND RULES OF THE 3. **MEMBERS**

- The Lead Member shall act as a Private Developer as per definition of 3.1 Lucknow Development Authority.
- The Lead member shall solely or jointly be authorized to negotiate and transfer 3.2 the developed properties of all consortium members.
- The Lead member shall of its own arrange and provide required finance for 3.3 the Project from its commencement till its completion.
- The Lead Member shall make payment for all costs and expenses incurred in 3.4 connection with the development and construction of the Project.
- The Lead Member shall pay the marketing and selling costs and expenses in 3.5 connection with Project.
- The Lead Member shall defend, compromise and settle all suits, proceedings 3.6 and cases that may be initiated by any third party or Government agency in connection with the Project and/ or approvals, permissions and sanctions granted therewith.
- The Lead Member shall pay any other costs and expenses relating to the 3.7 development, construction, marketing and sale of the Project.

4. FUNDING AND PROFIT SHARING

Any such notice, if sent, to/by either of the Parties shall be deemed to be issued and served on the Other Party.

6. ASSIGNMENT

Any Party of this Consortium shall not be entitled to assign and/or transfer their rights, partially or wholly in the Consortium to any third person(s), without the written consent of the Parties hereto.

7. ENTIRE AGREEMENT

This Consortium Agreement constitutes the entire agreement between the Members in respect of the Project. Any amendments or changes to this Consortium shall be valid only if made in writing and signed by each of the Members.

8. SEVERABILITY

If any provision of this Agreement is held to be invalid or unenforceable, in whole or in part, such provision shall be deemed not to form part of the Agreement and the validity and enforceability of the remainder of this Agreement will not be affected by any such invalidity or unenforceability.

9. VALIDITY

This Consortium Agreement shall be valid and enforceable till the completion 9.1 of the Project and can not be terminated by any of the Consortium members through mutual consent, or otherwise till the completion of the Project.

10. **GENERAL**

All documents and information exchanged between the Consortium Members, for the purpose of this Project, shall be treated as strictly confidential by the other Consortium Members and shall not be shared with any outside agency, except with Development Authority and to the extent required to be advised to the Development Authority in accordance with the terms of the Project.
- None of the Parties shall be held responsible or liable for not performing or 10.4 delay in performing any of its obligations as provided herein, if such performance is prevented, delayed or hindered by any reason/s, which are due to enemy action or natural calamities or Act of God or strike, lockout, or other labour disorder, act of foreign or domestic de jure or de facto Government, whether by law, order, legislation decree, rule, regulation or otherwise, revolution, civil disturbance, breach of the peace, declared or undeclared war, act of interference or action by civil or military authorities or any other cause beyond control.

11. SETTLEMENT OF DISPUTES

All the Parties agree to settle amicably all disputes arising out of or concerning this Consortium agreement. In the event of the members failing to amicably resolve any dispute in the foregoing manner, the matter shall be referred to the sole arbitrator to be decided mutually, whose decision shall be binding. The Arbitration shall be governed by the Arbitration and Conciliation Act 1996, including any statutory modification or amendment thereto. The venue for the Arbitration will be at New Delhi and the decision of the arbitrator shall be final and binding on the parties.

12. JURISDICTION

This Consortium Agreement shall be construed and the legal relations 12.1 between the Parties hereto shall be determined and governed according to the laws of India.
