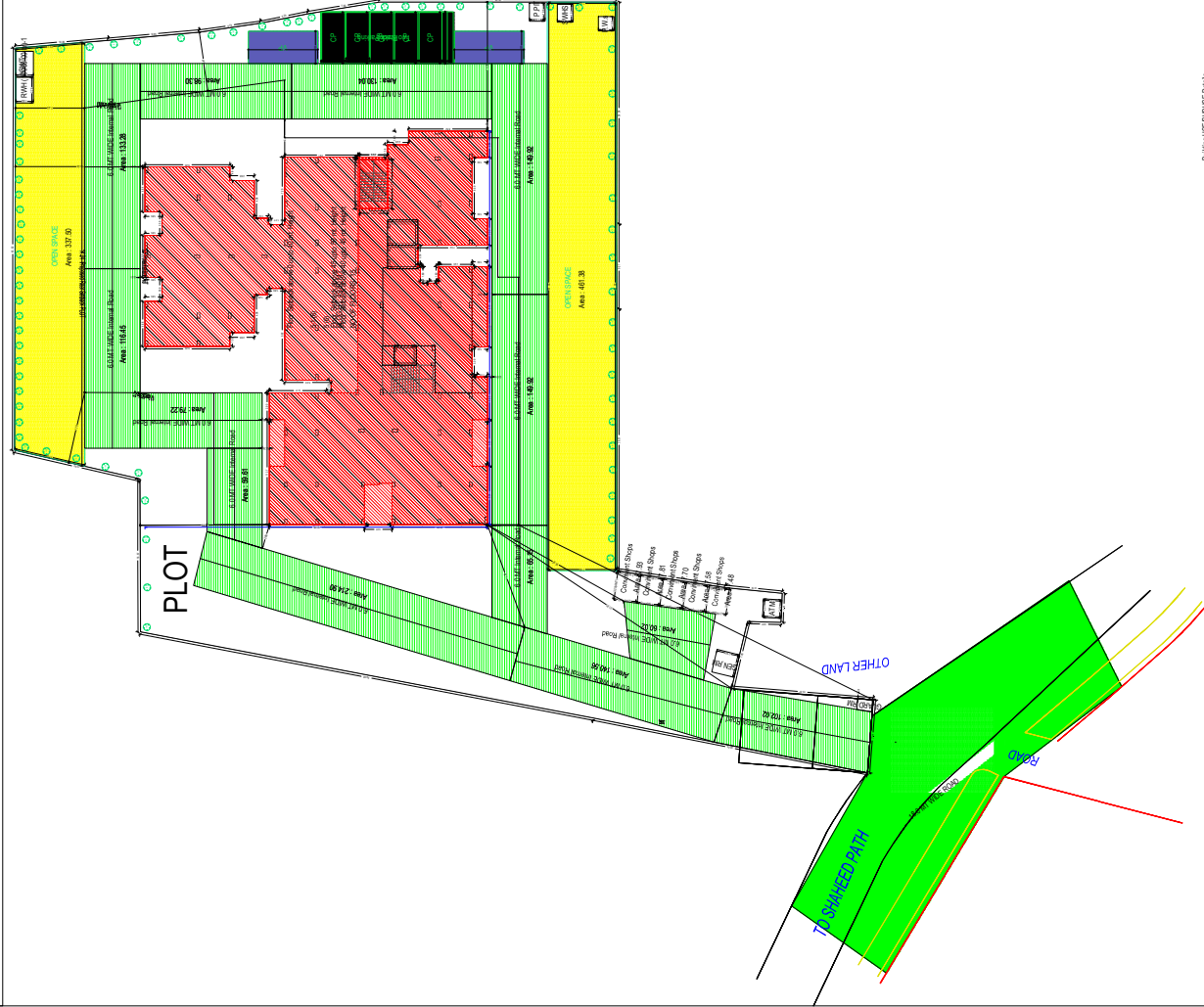
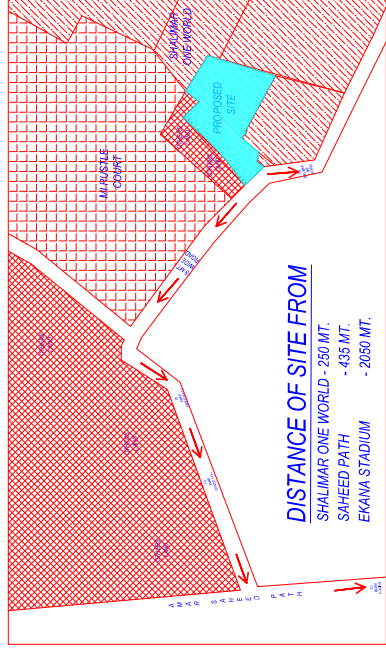




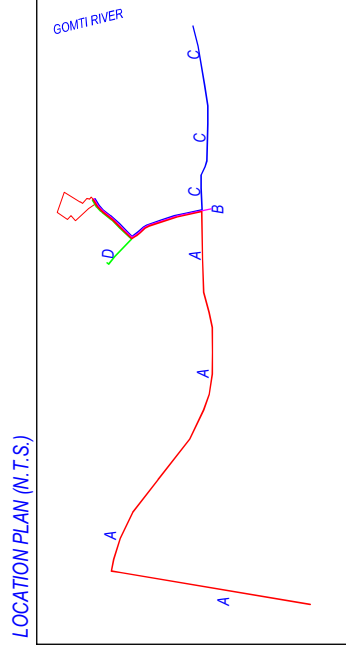
SITE PLAN
