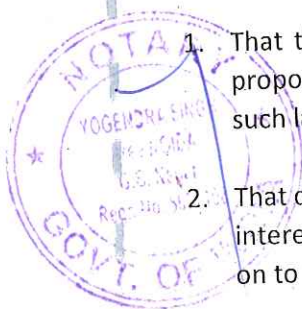

4.
