That, seventy per cent of the amounts realized by me/Promoter for the real estate project from the allottees, from time to time shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 4. That, the amounts from the separate account to cover the cost of the project shall be withdrawn in proportion to the percentage of completion of the project.
- 5. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered account and in practice that the withdrawal is in proportion to the percentage of completion of the project.
