

- 3. That on or before 20.02.2025 the Nirala Aspire Phase-III project shall be completed by G3 Aspire Nirala Gold LLP.
- 4. That seventy per cent of the amounts realized by the promoter for this real estate project from the allotees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
