



Subject: Issue of 'OC' for increase in the height of Integrated township at Milages V strault, Langana Disna, Ghaziabad by M/s Landcraft Developer: Pvt Ltd.

Sir,

I am directed to refer to your letter No. LDPL/09-10/09423 dated 23.04.09 on the above subject and to say that Air HQ has no objection from aviation angle for increase in the height of the proposed integrated township at Village Mahrauli, Pargana Dasna, Ghaziabad (revised Co-ordinates Latitude - 28° 39' N Longitude - 77° 28' E) by M/s Landcraft Developers Pvt Ltd, subject to the following conditions:-

- a) Height of the buildings shall not receded 20 meters.
- b) Standard obstruction lightings to be provided by the company. The lights shall be switched on during night and poor visibility.
- c) Periodic maintenance of obstruction lightings to be carried out by the company/housing society/tenants at regular intervals to keep them in visible/serviceable condition.
- d) Closed garbage containers shall be made available in order to ensure avoidance of bird activity.
- e) The commencement, completion of works and installation of obstruction lights shall be intimated to AOC, AF Stn Hindon.
- f) Required security clearance should be obtained through MHA/IB of the foreign Nationals/Indian representative employed/to be employed by the company in India.
- 2. You are also requested to obtain No Objection from other concerned Government Organization/Agencies as required.
