- Cheques / Draft to be given in the name of "SIDDHANT DEVELOPERS" payable at Varanasi.
- 2. Stamp-Duty & Registration charges shall be borne by the purchaser as per the rules.
- 3. In the case of cancellation of booking, the amount without interest shall be refunded after deducting the cancellation charges of 10% of total flat value while entertained only after expiry of 120 days of the written notice of withdrawal.

- 5. The layout plan of the complex and size of the unit is tentative. In case of any increases or decreases in area of the unit, the concerned person shall be informed accordingly.
