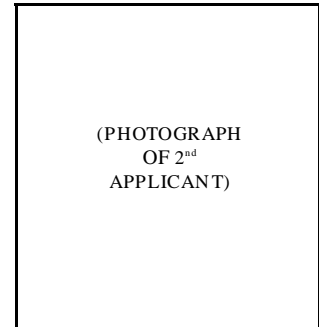
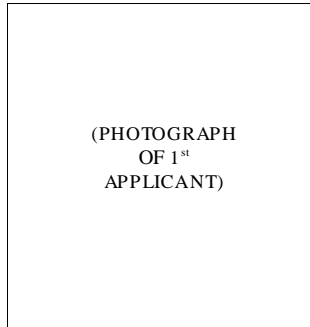

## 1. TITLE

- i) The Said Project (Vardhman Canary Park) is being developed on land owned by M/s Ajanta Colonizers Ltd. Meerut (hereinafter referred to as “The Developers”), situated at Kaseru Buxer , Ganganagar, Mawana Road, Meerut.
- ii) The applicant(s) has/ have understood that he/she/they is/are making the application to the said Developer, who is the absolute owner and fully authorized to develop and sell residential houses/plots/flats, (hereinafter referred to as house/plot/flat). The applicant(s) has/ have perused the title deeds of the \_\_\_\_\_s of the Developer in the said land, on which this project is being developed and has/have understood all limitations and obligation in respect thereof and further satisfied himself/ herself/, themselves about the right, interests and entitlement of the Developer to sell the house/ plot/ flat and receive the sale consideration.

## 2. ALLOTMENT

- i) Developer will receive the said application form duly filled on “First come first serve basis” and preference for allotment of house/plot/flat will be on the basis of priority numbers.
- ii) The intending applicant shall, within 15 days from the date of issuance of confirmation letter from the Developer, be required to sign the “Buyers Agreement” in the Developer’s prescribed format. #### **4. CONVEYANCE**

That the time for payment of installments as stipulated in the Payment plan as given in the application shall be the essence for allotment. In case, of any default by the applicant in making payment of the installments as per the payment plan, the applicant shall not be entitled for allotment and in the event allotment is already effected, such allotment shall be cancelled. Upon such cancellation, the Developer shall forfeit the registration cum Earnest Money amount ( 10% of the Total Price ) out of the amounts already paid by the applicant under this application.
