Mayur Vihar Phase-III, East Delhi-110096 (hereinafter referred to as "the Promoter"), for its proposed project namely "CRC MAESTA", vide board resolution passed in its board meeting dated 01.05.2024.

- I, Gopal Goyal, duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:
 - 1. That Comely Buildtech India Private Limited has a legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
