As the site is located at a distance of 24773 m from the Aerodrome reference point of Safdarjung Airport airport and the requested top elevation is 285 mtrs, the NOC for height clearance is not required from Airports Authority of India as per GSR 751(E).

a. The site-elevation and site coordinates provided by the applicant are taken for calculation of the permissible top elevation for the proposed structure. 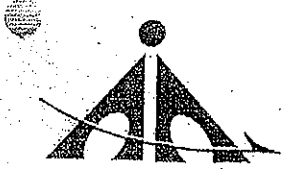
