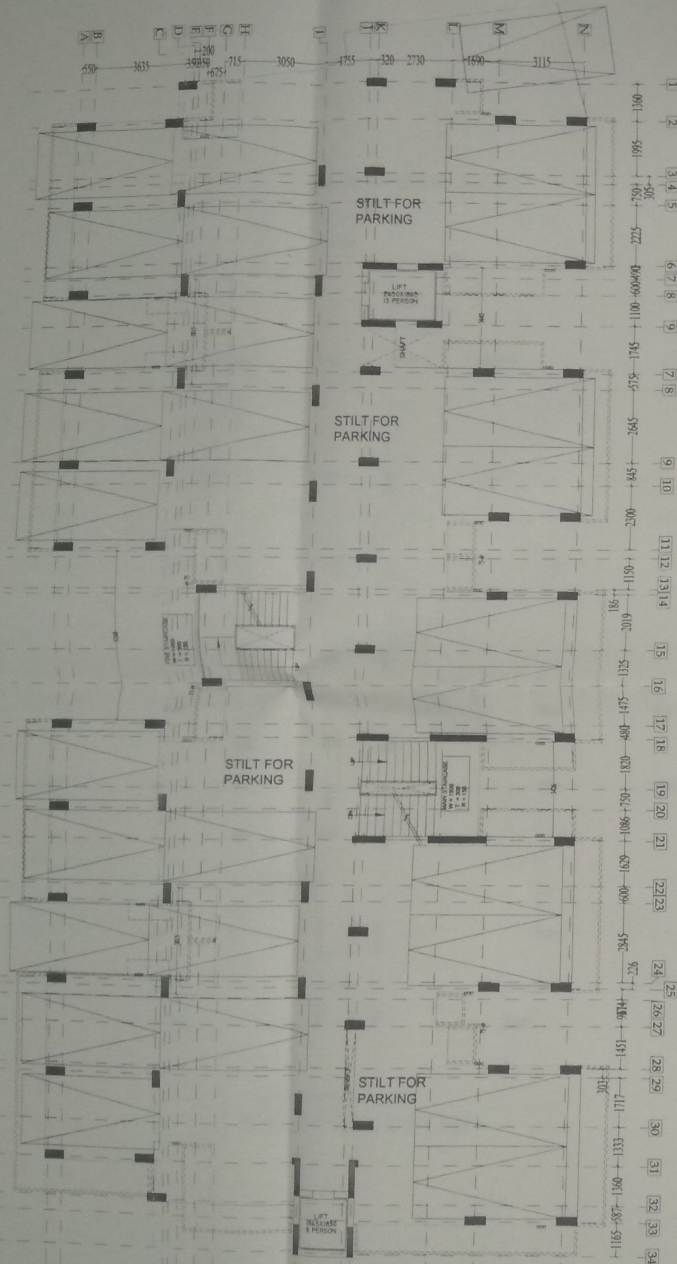

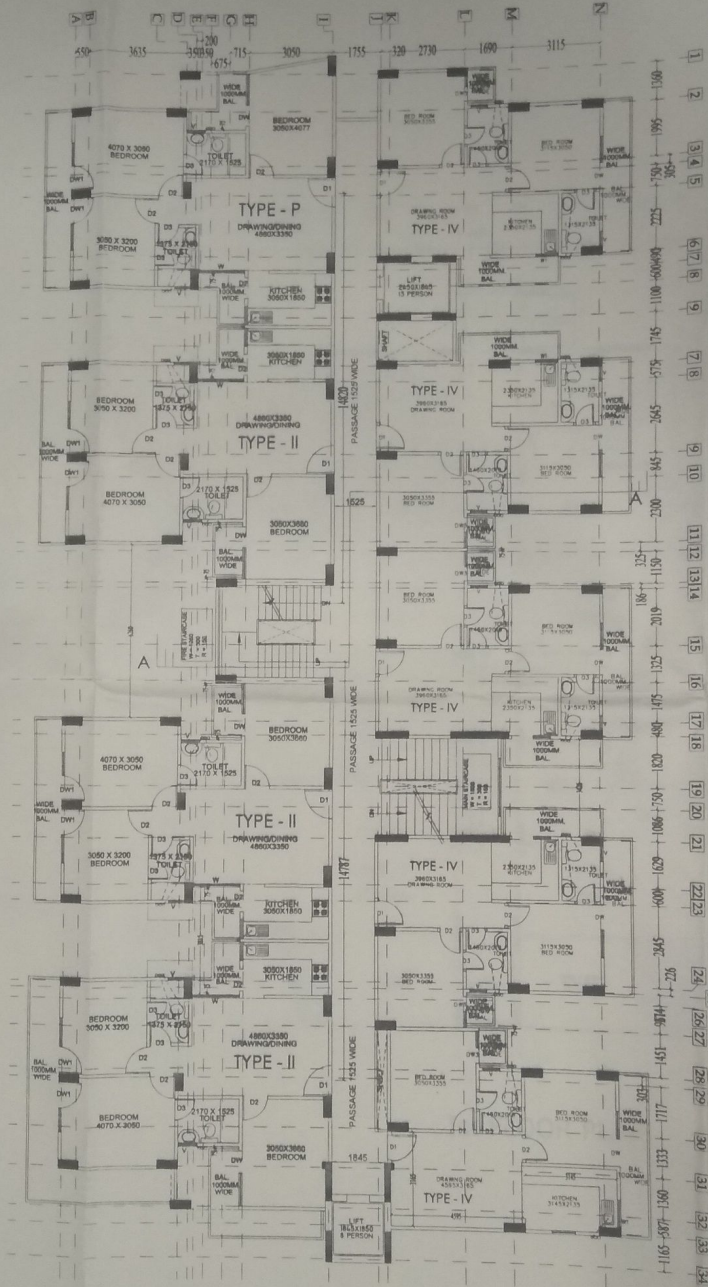


STILT FLOOR PLAN

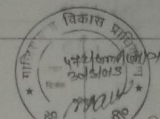
ADJOINING (CONVINIENT SHOPPING)
