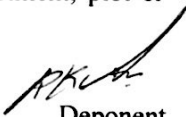


3. That the time period within which the project shall be completed by Director's of M. R. Proview Realtech Pvt. Ltd. is _____.
4. That seventy per cent of the amounts realized by Director's of M. R. Proview Realtech Pvt. Ltd. for the real estate project Shalimar City Phase-1 from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the Shalimar City Phase-1 project, shall be withdrawn in proportion to the percentage of completion of the project.
