- That the amounts from the separate account, to cover the cost of the Shalimar City 5. Phase-2 project, shall be withdrawn in proportion to the percentage of completion of the project.
- That the amounts from the separate account shall be withdrawn after it is certified by 6. an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
