- **1.** Applicant(s)/Allottee(s) has taken all information about the project from the website of Real Estate Regulatory Authority/website of Company.
- 2. Applicant(s)/Allottee(s) has understood the Total Sale Price payable by Applicant(s)/Allottee(s) and each component comprising the Total Sale Price. Applicant(s)/Allottee(s) has understood that in case of any increase/decrease in rate of Tax/Charge/Levy by government or in case of levy of any fresh Tax/Charge/Levy by government, Total Sale Price payable by Applicant(s)/Allottee(s) shall increase/decrease accordingly.
