This office has no objection to the proposed Construction of Group Housing by. M/s Kaveri Sahakari Awas Samiti herein after referred to as the applicant(s) at location Kh. No- 123 & 155, Village illahabans, Sector-86, Noida, U.P (Co-ordinates - 28 31 38 N 77 24 52 E) for a height of 60.00 Mts. (in Figure) Sixty Decimal Zero Meters (in words) above ground level so that the top of the proposed structure when erected shall not exceed 199.00 Mts (In figure) One Hundred Ninety Nine Decimal Zero Meters (site elevation) plus(+) 60.00 Mts (In figure) Sixty Decimal Zero Meters (height of structure) = 259.00 Mts. (In figure) Two Hundred Fifty Nine Decimal Zero Meters above meanisea level.

This no objection certificate is being issued on the express understanding that the site elevation (height above mean sea level) viz 199.00 Mts. relative location of the proposed building/structure & its distances and bearings from APPI Runway ends, as tendered by the applicant(s) are correct. If, however, at any stage it is established that the said da as tendered & which could adversely effect aircraft operations, the structure or part(s) thereof in respect of which this No Objection Certificate' is being issued will have to be demolished at his own cost as may be directed by the Airports Authority of India. The Applicant(s) are therefore advised in his /their own interest to verify the elevation and other data furnished for the site, before embarking on the proposed construction.

The issue of this 'NOC' is further subject to the provisions of Section 9-A of the Indian Aircraft Act, 1934 and those of any notifications issued there under from time to time and under which also the applicant may be called upon by the Airports Authority of India (National Airports Division) to demolish in whole or in part the structure now being

authorized vide this 'No Objection Certificate'.

The use of electric fire or oil fired furnace is obligatory.

This certificate is valid for a period of Five years from the date of issue if the building /structure /chimney is not constructed & completed within the above mentioned period of Five Years, you will be required to obtain a fresh No Objection Certificate from the Airports Authority of India(National Airports Division) and/cr the General Manager, Aerodrumes, Northern Region. The date of completion of the building/ structure/chimnry should be intimated to the Airports Authority of India and/or the General Manager, Aerodromes, Northern Region.

No light or a combination of lights which by reason of its intensity, configuration or colour may cause confusion with the aeronautical ground lights of the Airport shall be installed at the site at any time during or after the construction of the building.

Day & Night markings with secondary power supply may be provided as per ICAO Standard.

"The permissible top elevation/height includes beight for superstructures(eg. Wireless, TV antennas, mumties, lift machine room, overhead water tank cooling towers etc.)". OTE:- THE SITE IS EXAMINED WIRT IGH AIRPORT AND SAFDARJUNG AIRPORT ONLY.
