- That the construction of the Tower A B D E is proposed / likely to be completed by October 2020 and possession of the unit as proposed by July 2021 shall be handed over in all the respect.
- 4. That seventy per cent of the amounts realised by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained with the lender to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the Project, shall be withdrawn in proportion to the percentage of completion of the project.
- That the amounts form the separate account shall be withdrawn after it is certified by an
  engineer, an architect and a chartered accountant in practice that the withdrawal is in
  proportion to the percentage of completion of the project.
