I Promoter of the proposed project / duly authorized by the promoter of the proposed project, do hereby solemnly declare, undertake and state as under:

1. Uttar Pradesh Housing and Development Board have a legal title to the land on which the development of the proposed project is to be carried out. AND

That Uttar Pradesh Housing and Development Board shall get the amount audited within six S months after the end of every financial year by a chartered accountant in practice and shall y produce a statement of accounts duly certified and signed by such chartered accountant and it her shall be verified during the audit that the amounts collected for a particular project have been Sue utilized for the project and the withdrawal has been in compliance with the proportion to the 0.1 percentage of completion of the project.
8. That Uttar Pradesh Housing and Development Board shall take all the pending approval on time from the competent authorities.
9. That, Uttar Pradesh Housing and Development Board have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
10. That Uttar Pradesh Housing and Development Board shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
